

SOUL JOURNEYS® METHOD Akashic Record Certification Program

REQUIREMENTS FOR CONSULTANT CERTIFICATION (subject to change):

Level One - a) 8 hours of in-class study; b) 30days of opening Records to integrate energy for a minimum of 15 minutes per day prior to Level 2; **\$297pp**

Level Two - a) 8 hours of in-class study; b) 5 hours of self-consults and 5 hours of practice consults with others 30days prior to Level 3 (this is flexible depending on readiness); **\$325pp**

****charging for consults with others occurs after successful completion of Level 3*

Level Three - a) 8 hours of in-class study; b) 90 days of self consult and consults with others for a minimum of 10hrs each; c)consultation in your Records with your Level Three teacher to ascertain if consultations can be offered on a fee for service basis; d) once complete, your name and contact information will be added to the website so that potential clients can identify you as a certified consultant through the Soul Journeys® Method; **\$325, plus cost of 2 consults with Jennifer**

****to maintain certification, you must take this Level at least once per year including bi-annual consults with teacher to ensure personal development, learning and growth as a consultant*

***Advanced Training** - (i.e. co-creating with God, dimensional shifting, advanced techniques in the Record....topics will vary each year) - a) 12 hours of in-class study over 2 days; **\$625pp**

** This class is optional for those wishing to further their development as a consultant and is required for those wishing to teach Level One or Two. Enrollment in this course does not guarantee teacher certification. The readiness factor must also be present.*

REQUIREMENTS FOR TEACHER CERTIFICATION (*subject to change):

Teaching Level One - a) completion of Levels One to Three and a certified consultant in good standing; b) a minimum of 200hrs of consultation with others and 100 hours of consultation with self with dates and journals of self-consults reviewed with teacher to be eligible for teacher certification; c) interning in a minimum of 2 Level One Classes before your name and contact information is added to the website for potential clients to locate you as a certified Level One Teacher; d) quarterly consultations with teacher annually, 50 hours of self consults reviewed with teacher, and attendance at 1 advanced training per year to maintain teacher certification

\$750pp one-time fee, plus 3 consultations/year with Jennifer and 1 advanced training/year



Teaching Level Two - a) a certified Level One teacher in good standing having taught a minimum of 3 Level One Classes; b) interning in a minimum of 3 Level Two Classes before your name and contact information is added to the website for potential clients to locate you as a certified Level Two Teacher; c) quarterly consultations with teacher annually, 50 hours of self consults reviewed with teacher, and attendance at 1 advanced training per year to maintain teacher certification; **3 consultations/year with Jennifer and 1 advanced training/ year**
